
2. **Eligibility Conditions of Director (Finance & Administration) :-** Deputation (Including short term contract) Officers under the Central Government or State Government or UTs or Universities or Recognized Research Institutions or Public Sector Undertakings or Semi-Government or Statutory or Autonomous Organizations:-

- (A) **(i) Holding analogous posts on regular basis in the parent cadre or department; or**
(ii) With five years' service in the grade rendered after appointment thereto on a regular basis in posts in Level-12, Rs. 78800-209200 of pay matrix or equivalent in the parent cadre or Department; or
(iii) With ten years' service in the grade rendered after appointment thereto on a regular basis in the posts in Level-11, Rs. 67700-208700 of pay matrix or equivalent in the parent cadre or department; and
- (B) **Possessing the following educational qualification and experience:**
(i) Bachelor's degree from a recognized University;
(ii) Twelve years' experience in the field of administration including five years experience in finance matters including budget and accounts.

List of Duties/Responsibilities attached to the post of Director (Finance & Administration):-
Director (Finance & Administration) will assist Technical Experts & Chief Executive Officer (CEO) in Financial and Administrative matters.
